12 **AVAILABILITY**

13
14 This schedule is available at any point on the Energy Department electric system where
15 facilities of adequate capacity and standard residential voltages are available.
16

17 **APPLICATION**

18
19 This schedule is applicable to electric service used exclusively for residential purposes
20 for (1) individually metered single-family dwelling units, (2) individually metered
21 dwelling units in duplexes, triplexes, apartments and condominiums and (3) duplexes and
22 triplexes that existed prior to 1990 and are served through a single electric meter. This
23 schedule is not applicable to residential dwellings used for business purposes separately
24 metered garages, workshops, barns or similarly detached structures which may be
25 associated with a primary residential dwelling but not inhabited by humans for domestic
26 purposes. This schedule is not applicable to licensed boarding or rooming houses served
27 by a single meter.

29 **CHARACTER OF SERVICE**

30
31 Service under this schedule shall be single-phase, 60 Hertz, alternating current at the
32 Energy Department's available standard residential voltage. At the option of the Energy
33 Department, three-phase service may be provided. All residential service required on the
34 premises by the customer will be supplied through one meter. Standby or resale service is
35 not permitted under this schedule.

MONTHLY RATE

The monthly billing for electric service, excluding charges for other utility services and taxes, shall be the sum of the following charges:

Customer Charge:	\$13.92 per Service Connection
Energy Charge:	\$0.0734 per kWh for the first 500 kWh
Energy Charge:	\$0.1019 per kWh for 501-1000 kWh
Energy Charge:	\$0.1209 per kWh per all additional

AMI METER OPT OUT

\$10.00 per month

MINIMUM CHARGE

The minimum monthly charge shall be the Customer Charge listed above under the Monthly Rate section.

TAX ADJUSTMENTS

The amount computed at the above Monthly Rate shall be subject to taxes, assessments and surcharges imposed by Provo City or any governmental authority authorized to levy said taxes, assessments or surcharges.

TERMS AND CONDITIONS

Service under this schedule will be in accordance with the Energy Department's electric service standards and policies and terms and conditions set forth by the Department's standard application requirements and Provo City Ordinances, including any future additions or amendments.
