3 **PROVO CITY ENERGY DEPARTMENT**
4 **ELECTRIC SERVICE SCHEDULE NO. 4**

7 **General Service -- Primary Voltage**
8

9
10 **AVAILABILITY**

11
12 This schedule is available at any point on the Energy Department electric system where facilities
13 of adequate capacity and standard primary voltage levels are available.

14
15 **APPLICATION**

16
17 This schedule is applicable to electric service used for, but not limited to, retail or wholesale
18 businesses, manufacturing or processing establishments, offices, hotels, motels, churches and
19 separately metered common areas of apartment or condominium complexes. This schedule is
20 only applicable where the customer takes service from the Electric Department’s available lines
21 of 4,000 volts or higher and provides and maintains all transformers and other necessary
22 equipment located on the customer’s side of the primary metering equipment.

23
24 **CHARACTER OF SERVICE**

25
26 Service under this schedule shall be three-phase, 60 Hertz, alternating current at the Energy
27 Department’s available standard primary voltages. All service required on the premises by the
28 customer will be supplied through one primary voltage meter. Standby or resale service is not
29 permitted under this schedule. Customer is responsible for providing, installing, and maintaining
30 all service equipment (including overhead service entrance conductors, conduit, enclosures, and
31 meter sockets).

32
33 Meters shall be accessible by the Energy Department at all times for reading, maintenance, and
34 emergencies.

35
36 **MONTHLY RATE**

37
38 The monthly billing for electric service, excluding charges for other utility services and taxes,
39 shall be the sum of the following charges:

41	Customer Service Charge: \$30.16 per Service Connection
42	Demand Charge: \$12.60 per kW
43	Energy Charge: \$0.0446 per kWh

50 **DEMAND METERING**

51
52 The kW billing demand shall be the highest measured 15-minute kW for the billing period,
53 adjusted for power factor as specified in this schedule.

54
55 **POWER FACTOR**

56
57 The Energy Department may, at its option, install metering equipment to allow the utility to
58 determine the reactive components of power utilized by the customer. The customer’s utilization
59 of equipment shall not result in a power factor at the point of delivery of less than 90% lagging
60 at the time of maximum demand. Should the power factor be less than 90% lagging during any
61 month, the Energy Department may adjust the readings taken to determine the billed demand by
62 multiplying the kW obtained through such readings by 90% and by dividing the result by the
63 power factor actually established at the time of maximum demand during the current month.
64 Such adjusted readings shall be used in determining the billing demand.

65
66 The Energy Department reserves the right, at its option, to utilize kVA meters, kVAR meters,
67 and / or other appropriate meters in those metering installations where the customer’s power
68 factor is believed to be unsatisfactory on a continuous basis according to the Energy
69 Department’s standards. If such meters are installed, the billing demand in kW or kVA may be
70 computed from such instruments.

71
72 **MINIMUM CHARGE**

73
74 The minimum monthly charge shall be the Customer Charge listed above under the Monthly
75 Rate section.

76
77 **TAX ADJUSTMENTS**

78
79 The amount computed at the above Monthly Rate shall be subject to taxes, assessments and
80 surcharges imposed by Provo City or any governmental authority authorized to levy said taxes,
81 assessments or surcharges.

82
83 **TERMS AND CONDITIONS**

84
85 Service under this schedule will be in accordance with the Energy Department’s electric service
86 standards and policies and terms and conditions set forth by the Department’s standard
87 application requirements and Provo City Ordinances, including any future additions or
88 amendments.
