

**PROVO CITY ENERGY DEPARTMENT  
ELECTRIC SERVICE SCHEDULE**

**PILOT OPTIONAL EV TIME-OF-USE  
(RESIDENTIAL)  
NO. 3.1**

**AVAILABILITY**

This schedule is available at any point on the Energy Department electric system where facilities of adequate capacity and standard general service distribution voltages are available. This schedule shall be available to up to 100 customers on a first come, first served basis, and upon the installation of required Time-of-Day metering equipment. If such installation may be delayed due to installation schedules or limited availability of such metering equipment, customers shall be placed on a prioritized list for service as such installation schedules or metering equipment become available.

**APPLICATION**

This optional schedule is for electric service used exclusively for residential purposes in conjunction with Schedule 1. Applicable to all household energy use for homes with qualifying EV charging system.

**CHARACTER OF SERVICE**

Service under this schedule shall be single-phase, 60 Hertz, alternating current at the Energy Department’s available standard general service distribution voltages. At the option of the Energy Department, three-phase service may be provided. All service required on the premises by the customer will be supplied through one meter. Standby or resale service is not permitted under this schedule.

**MONTHLY RATE**

The monthly billing for electric service, excluding charges for other utility services and taxes, shall be the sum of the following charges:

<b>Customer Service Charge:</b>	\$15.92 per Service Connection
<b>On-Peak Energy Charge:</b>	\$0.1700 per kW/h
<b>Off-Peak Energy Charge:</b>	\$0.0769 per kW/h
<b>Super Off-Peak Energy:</b>	\$0.0450 per kW/h

**ON AND OFF-PEAK TIME PERIODS**

On-Peak	3:00 pm to 8:00 pm, Monday through Friday, except holidays.
Off-Peak	8:00 am to 3 pm and 8 :00 pm to midnight, Monday through Friday and 8:00 am to midnight, Saturday, Sunday, and holidays.
Super Off-Peak	Midnight to 8:00 am all days

47 Holidays include only New Year's Day, President's Day, Memorial Day, Independence Day,  
48 Pioneer Day, Labor Day, Thanksgiving Day, and Christmas Day. When a holiday falls on a  
49 Saturday or Sunday, the Friday before the holiday (if the holiday falls on a Saturday) or the  
50 Monday following the holiday (if the holiday falls on a Sunday) will be considered a holiday and  
51 consequently off-peak.

53 **MINIMUM CHARGE**

54 The minimum monthly charge shall be the Customer Charge listed above under the  
55 monthly rate section.

57 **SPECIAL CONDITIONS**

58 1. Customer on this tariff schedule shall have a term of not less than one year.  
59 Service will continue under this schedule until Customer notifies the Company  
60 to discontinue service.

62 2. Billing under this schedule shall begin for the Customer following installation  
63 of the time-of-use meter and the initial meter reading.

65 3. The Energy Department will not accept enrollment for accounts that have:

- 66 a. Time-payment agreement in effect
- 67 b. Received two or more final disconnect notices
- 68 c. Been disconnected for non-payment within the last 12 months
- 69 d. Enrolled in other specialized rates including net-metering and  
70 RenewChoice options or budget billing
- 71 e. Energy consumption under 500 kW/h for more than 6 months of the  
72 year.

73 4. Shall have qualifying EV charging system.

74

75 **TAX ADJUSTMENTS**

76 The amount computed at the above monthly rate shall be subject to taxes, assessments  
77 and surcharges imposed by Provo City or any governmental authority authorized to levy  
78 said taxes, assessments, or surcharges.

80 **TERMS AND CONDITIONS**

81 Service under this schedule will be in accordance with the Energy Department's electric  
82 service standards and policies and terms and conditions set forth by the Department's  
83 standard application requirements and Provo City Ordinances, including any future  
84 additions or amendments.
